Nationwide Post-Budget Breakfasts Friday 17 May

Each year Child Poverty Action Group (CPAG) provides child-focused analyses and commentary of the year's budget. This year is CPAG's 13th annual budget breakfast series with events being held in three main centres - Auckland, Wellington and Christchurch. The aim is to provide an accessible and affordable avenue for the community to come together and hear about how the budget affects children and young people, especially our most vulnerable who live in poverty.

In addition to the events themselves, CPAG intends to provide a comprehensive budget briefing package which will be available the



day after the budget is released. Many speaker presentations will also be available from CPAG's website.

Message from CPAG's Chair

Child poverty remains a critical issue for New Zealand's economic and social policy and sadly this government shows little interest in effective action. If we are serious about the position of New Zealand's children and about providing all children with the best possible opportunities then this year's budget and the Appeal Court case later this month are critical in advancing the interests and wellbeing of the country's poorest and most disadvantaged children. Our budget breakfasts this month will provide a very good opportunity to hear about government intentions and directions while the Court case the following week is an important opportunity to again argue the case against the discrimination experienced by New Zealand's poorest children. Susan St John and those working with her have done a tremendous amount of work on the Court case and we look forward to the Court's response with a great deal of anticipation. There is a lot of public concern about child poverty; the crucial task is to translate that into effective action.

A Fair Go for ALL Kiwi Kids Appeal Update

CPAG is challenging government in court over legislation which unfairly discriminates against 230,000 of New Zealand's poorest children, many of whom live in severe and persistent hardship. Removing this discriminatory policy would be one practical and just way to address the appalling level of child poverty in our country.

CPAG was very pleased to have a full page article published in the New Zealand Herald linking the current debate on child poverty to this issue, [Susan St John: Lets have policies for all children](#). We have also been writing to and/or meeting with various stakeholders to build support for the upcoming case—political parties, social sector organisations and other influential public persons.

Our fundraising and awareness efforts continued, with events held in both Auckland and in Wellington.

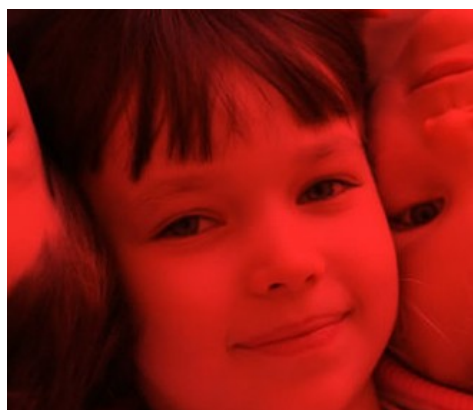

This quarter CPAG has also been busily preparing for our upcoming Court of Appeal hearing on 28 and 29 May. CPAG submissions were due on 22 April and the reply submissions to Crown cross appeal (on s19) on 6 May. Due to the case being of 'considerable public interest', CPAG was also granted a waiver with regard to court fees. The Human Rights Commission is submitting an independent intervention at the Court of Appeal.

CPAG understands this issue can be difficult to grasp, so in the lead up to the hearing, CPAG will be running an education campaign about the unfairness of the Working for Families In-work Tax Credit. Look out for our case studies, using real life examples of children and their families which illustrate the many different ways our children lose out through no fault of their own.

Join us at the Court of Appeal 28 – 29 May

A number of CPAG executive members will be attending the Court of Appeal hearing and we strongly urge all our Wellington based supporters to come along as well. Packing the court out on both days will send a very strong message. Please join us as a mark of solidarity at the Court of Appeal, 54 Molesworth Street, Thorndon, Wellington.

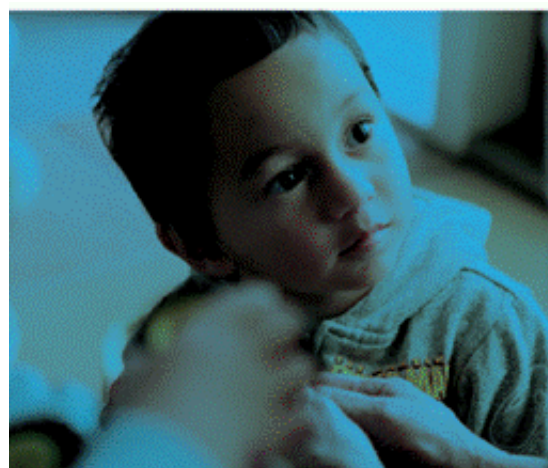

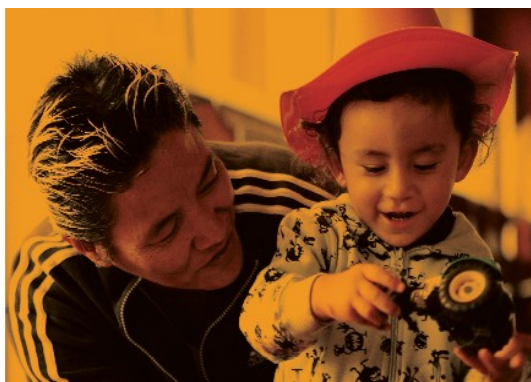

Glen Inquiry into Child Abuse

In response New Zealand's alarming child abuse and domestic violence statistics, Sir Owen Glenn has funded an independent inquiry with the goal to develop an evidence-based, solution focused proposal to addressing this multi-faceted problem. Janfrie Wakim, former CPAG director and founding member has been asked to be part of the inquiry's 'Think Tank' panel which will help to ensure CPAG's perspective is heard. CPAG is also pleased to see a number of its supporters and collaborators on the panel.

Tying in with this work and that of the White Paper on Vulnerable Children, CPAG is currently finalising a monograph publication regarding the links between child abuse and child poverty which will be released in the next quarter. This will be the first paper in a two part series on this issue.

Welcome Rawiri Wharemate

In addition to Management Committee (MC) members being elected, CPAG's constitution allows the elected MC to 'co-opt' or invite others to join the committee in order to broaden the range of expertise CPAG can regularly draw on. CPAG enthusiastically welcomes Rawiri Wharemate (Ngapuhi, Ngatiwai, Ngai Te Rangi, Tainui) as a co-opted MC member. Rawiri is the Kaumatua at the Werry Centre (Child and Adolescent Workforce Development). He has extensive experience working with indigenous peoples, both in New Zealand and internationally at the United Nations. Rawiri is currently developing a Tangata Whenua Framework which will form an important foundation for CPAG's work.

CPAG Young Person's Network (CPAGY)

In response to large numbers of requests from students regarding how they can help, CPAG Auckland has formed a Young Person's Network which meets every third Monday of the month. Everyone is welcome.
